1. CONTESTANTS WILL WEAR TWO OUTFITS DURING THE PAGEANT: A SUITABLE CASUAL OUTFIT & KNEE LENGTH SPECIAL OCCASION DRESS (NO GOWNS/COSTUMES). AUDITORIUM STAGE ENTRANCE DOORS WILL BE OPENED AT 2:00PM FOR CONTESTANTS. CONTESTANT MUST ARRIVE AT FLAGLER AUDITORIUM WITH OUTFITS & HAVE ALL PAGEANT NECESSITIES WITH THEM BY 2:30 PM ON SUNDAY, JUNE 26, 2011 TO HELP LITTLE MISS CONTESTANTS.
 2. MISS JR. CONTESTANT WILL BE ASSIGNED A LITTLE MISS CONTESTANT TO ASSIST & SUPERVISE. YOU WILL NOT BE ALLOWED TO LEAVE THE AUDITORIUM BEFORE OR DURING YOUR PAGEANT, SO PLEASE BRING ANY DRINK OR SNACK YOU MIGHT NEED WITH YOU. ABSOLUTELY NO PARENTS, FRIENDS OR RELATIVES WILL BE ALLOWED BACKSTAGE OR IN DRESSING ROOMS AFTER 2:45PM ON PAGEANT DAY.
 3. WINNERS MUST PICK UP PRIZES AND AWARDS BETWEEN JULY 10, 2011 AND AUGUST 10, 2011 AT Z WAVE SURF SHOP, 400 S. OCEANSHORE BOULEVARD, FLAGLER BEACH.
 4. REHEARSAL DATE AND TIME TO BE ANNOUNCED.
 5. WINNERS WILL NEED TO BE AT MISS FLAGLER COUNTY PAGEANT AT 7PM IN DRESS & SASH ON THE SAME DAY TO BE INTRODUCED. WINNER MUST BE ABLE TO PARTICIPATE IN THIS YEAR'S 4TH OF JULY PARADE.
