****PAGEANT RULES****

1. CONTESTANTS WILL WEAR TWO OUTFITS DURING THE PAGEANT: AN APPROPRIATE ONE PIECE OR AN APPROVED TWO PIECE SWIMSUIT (NO TRI-TOPS/SKIMPY SUITS OR SARONGS) & A FORMAL ANKLE LENGTH GOWN. FOR THE INTERVIEW WITH THE JUDGES, AN ELEGANT OR BUSINESS OUTFIT SHOULD BE WORN. TATTOOS & BODY JEWELRY IS ONLY ALLOWED IF APPROVED BY PAGEANT DIRECTORS.
2. INTERVIEWS BEGIN PROMPTLY AT 5PM ON JUNE 26, 2011 AND USUALLY LAST TWO HOURS. ARRIVE BY 4PM COMPLETELY READY IN INTERVIEW OUTFIT AND BE PREPARED TO STAY UNTIL PAGEANT IS OVER. PAGEANT BEGINS AT 7PM YOU WILL NOT BE ALLOWED TO LEAVE THE AUDITORIUM, SO BRING ALL PAGEANT NECESSITIES. WE SUGGEST YOU BRING A SNACK & DRINK WITH YOU, SINCE YOU WILL NOT BE PERMITTED TO LEAVE OR GO OUTSIDE.
3. ABSOLUTELY NO PARENTS, FRIENDS, OR RELATIVES WILL BE ALLOWED BACKSTAGE OR IN DRESSING ROOMS AFTER 4:45P.M., SO PLEASE BRING EVERYTHING YOU WILL NEED FOR THE PAGEANT.
4. REHEARSAL DATE AND TIME TO BE ANNOUNCED.
5. WINNERS MUST PICK UP PRIZES AND AWARDS BETWEEN JULY 10, 2011 & AUGUST 10, 2011 AT Z WAVE SURF SHOP, 400 S. OCEANSHORE BLVD., FLAGLER BEACH.
6. WINNER MUST PARTICIPATE IN THE 4th OF JULY FESTIVITIES & IN VARIOUS OTHER FUNCTIONS THROUGHOUT THE YEAR. MISS FLAGLER COUNTY IS REQUIRED TO SIGN A PERSONAL APPEARANCE CONTRACT & ALL PUBLIC APPEARANCES MUST BE APPROVED BY MISS FLAGLER COUNTY PAGEANT DIRECTORS. PAGEANT, TITLE & PAGEANT PHOTOS MAY NOT BE REPRODUCED, REPRESENTED OR USED WITHOUT PERMISSION IN ANY MANNER.
7. APPLICANT PLEDGES THAT SHE IS A NATURALLY BORN FEMALE, OF GOOD HEALTH & MORAL CHARACTER, A CITIZEN OF THE UNITED STATES, IS NOT MARRIED, HAS NEVER BEEN MARRIED, HAS NEVER GIVEN BIRTH TO A CHILD, OR IS NOT NOW PREGNANT.
8. APPLICANT MUST TURN IN COMPLETED, TYPED ESSAY, APPLICATION & FLAGLER COUNTY BUSINESS SPONSOR CHECK BY DEADLINE, ALONG WITH A COPY OF DRIVER'S LICENSE AND BIRTH CERTIFICATE. APPLICANT MUST HAVE BEEN A FLAGLER COUNTY RESIDENT FOR A MINIMUM OF 1 YEAR PRIOR TO 6/26/11.
9. APPLICANT UNDERSTANDS THAT BY ENTERING MISS FLAGLER COUNTY SHE HAS THE POSSIBILITY, BUT NOT THE GUARANTEE, OF REPRESENTING FLAGLER COUNTY IN THE MISS FLORIDA USA PAGEANT AND THE NATIONAL FINALS OF THE MISS USA PAGEANT, IF ALL STATE ENTRY & MISS FLAGLER COUNTY REQUIREMENTS ARE MET, AND ATTESTS THAT SHE HAS NEVER PARTICIPATED IN A MISS USA PAGEANT.
10. APPLICANT GIVES PERMISSION TO BE PHOTOGRAPHED AND PERMITS HER NAME, LIKENESS, PHOTO, AND BIO TO BE USED WITHOUT CHARGE FOR ALL PUBLICITY, PROMOTIONAL/ADVERTISING MATERIAL, & ANY/ALL COMMERCIAL PURPOSES.
11. Z WAVE RESERVES THE RIGHT TO DEMAND THAT WINNERS & CONTESTANTS CONDUCT THEMSELVES IN A MANNER ACCEPTABLE AS A ROLE MODEL. 13. I UNDERSTAND THAT I AM FREE TO WITHDRAW FROM THE PAGEANT AT ANY TIME, BUT UNDER NO CIRCUMSTANCES WILL I BE ENTITLED TO A REFUND, EITHER FULL OR PART, THAT I OR MY SPONSORS HAVE PAID. THERE WILL BE NO EXCEPTIONS TO THIS POLICY.
14. I VOLUNTARILY DISCLOSE THAT PRIOR TO THE DATE OF THIS PAGEANT, I HAVE NOT ENGAGED IN ANY ACTIVITIES, WHICH IF DISCLOSED TO PUBLIC, WOULD BRING OR TEND TO BRING, MYSELF OR THE MISS FLAGLER COUNTY PAGEANTS, INTO DISRESPECT, RIDICULE, OR CONTEMPT.
15. Z WAVE & PAGEANT DIRECTORS RESERVE THE RIGHT TO DETERMINE ELIGIBILITY.
